実質 GDP 成長率に対する各内訳項目（項目  $i$ ）の寄与度計算は、以下のように行っている。

$p_{i,t}$  :  $t$  暦年の下位項目デフレーター,  $q_{i,t}^{(k)}$  :  $t$  暦年 (第  $k$  四半期) の下位項目数量指数,  $T$  :  $T$  年度 ( $t$  暦年第 2 四半期 ~  $t+1$  暦年第 1 四半期)

(1) 暦年計数 (前年比)

留意点

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る (純輸出実質額は「輸出-輸入」の実質額の単純引き算により求めるため)。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」の寄与度は、下位内訳項目の寄与度計とは一致しない。
