1. 季節調整系列について、1980(昭和55)年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1980(昭和55)年1-3月期まで遡りて改定されることから、最新の速報を利用されたい。
2. 実質値について、名目雇員報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
3. 2000(平成12)年10-12月期以前の四半期計数は、SNAホームページを参照されたい。

- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」の寄与度は、下位内訳項目の寄与度計とは一致しない。
