使用上の注意

1. 季節調整系列について、1980(昭和55)年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1980(昭和55)年1-3月期まで遡って改定されることから、最新の速報を利用されたい。
2. 実質値について、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
3. 1998(平成10)年10-12月期以前の四半期計数は、SNAホームページを参照されたい。

V. 寄与度の計算方法について

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る (純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求めるため)。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」の寄与度は、下位内訳項目の寄与度計とは一致しない。
