留意点

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る (純輸出実質額は「輸出-輸入」の実質額の単純引き算により求めるため)。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」の寄与度は、下位内訳項目の寄与度計とは一致しない。
