## 使用上の注意

### I. 国内総生産(支出側)及び各需要項目

1. 基礎資料の改定等に伴い、名目原系列については2013(平成25)年1-3月期以降、実質原系列については2012(平成24)年1-3月期以降の計数の改定が行われる可能性がある。
2. 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994(平成6)年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
3. 最新の全計数(1994(平成6)年1-3月期以降)については、SNAホームページを参照されたい。
4. 1999(平成11)年7-9月期については、公的部門から民間部門への大規模な資産譲渡が、2004(平成16)年1-3月期については、公的部門の民間部門からの大規模な資産購入が、いずれも民間企業設備及び公的固定資本形成に反映されていることに留意されたい。

### II. 形態別国内家計最終消費支出

形態別国内家計最終消費支出は、国内家計最終消費支出88目的分類の各項目を4つの形態(耐久財、半耐久財、非耐久財、サービス)のいずれかに分類して計上したものである。
