使用上の注意

I. 国内総生産(支出側)及び各需要項目

1. 基礎資料の改定等に伴い、名目原系列については2016(平成28)年1-3月期以降、実質原系列については2015(平成27)年1-3月期以降の計数の改定が行われている可能性がある。
2. 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994(平成6)年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
3. 本時系列表は、2007(平成19)年1-3月期以降を掲載している。最新の全計数(1994(平成6)年1-3月期以降)については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。
