使用上の注意

- 季節調整系列については、1994(平成6)年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1994(平成6)年1-3月期まで遡及して改定されることから、最新の速報を利用されたい。
- 原系列については、2018(平成30)年7-9月期1次QE時に、2009(平成21)年7-9月期以降の計数を遡及改定した。これは、基礎統計のひとつである「毎月勤労統計」(厚生労働省)において、2018(平成30)年1月からローテーション・サンプリングの導入等の変更が行われ、これを受け、雇用者報酬の推計方法の一部を変更したためである。
- 実質値については、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。 47
