使用上の注意

- 『毎月勤労統計』(厚生労働省)の500人以上規模事業所の再集計に伴い、2004年から2011年については暫定的な方法の補間推計となっている。
- 基礎統計の改定等に伴い、原系列については2019年7-9月期以降の計数が改定されている。
- 季節調整系列については、1994年1-3月期から直近期の原系列に季節調整を行い作成しており、毎回1994年1-3月期まで遡り改定されることから、最新の速報値を利用されたい。
- 実質値については、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
- 本時系列表は、2008年1-3月期以降に掲載している。最新の全計数(1994年1-3月期以降)については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。
