I. 国内総生産(支出側)及び各需要項目

1. 基礎資料の改定等に伴い、原系列については名目、実質ともに2017年1-3月期以降の計数の改定が行われている可能性がある。
2. 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
3. 本時系列表は、2009年1-3月期以降に掲載している。最新の全計数(1994年1-3月期以降)については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。
