使用上の注意

I. 国内総生産(支出側)及び各需要項目

1. 基礎資料の改定等に伴い、名目原系列については2021年1-3月期以降、実質原系列については2020年1-3月期以降の計数の改定が行われている可能性がある。
2. 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
3. 本時系列表は、2012年1-3月期以降を掲載している。最新の全計数(1994年1-3月期以降)については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。

II. 形態別国内家計最終消費支出

形態別国内家計最終消費支出は、国内家計最終消費支出88目的分類の各項目を4つの形態(耐久財、半耐久財、非耐久財、サービス)のいずれかに分類して計上したものである。

III. 形態別総固定資本形成

形態別総固定資本形成は、「I. 国内総生産(支出側)及び各需要項目」に表章されている総固定資本形成(民間住宅+民間企業設備+公的固定資本形成)の総額を供給側推計の情報等を用いて形態別に分類したものである。利用に当たっては、資料の制約から、各形態別に消費税控除額を求めることが困難であるため、四半期別GDP速報において公表する総固定資本形成の形態別分類は、四半期毎に、修正グロス方式による総額をグロス方式による形態別構成比で分割していることに留意願いたい。
