使用上の注意

- ・ 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
- ・ 季節調整系列については、実額を年率で表示している。
- ・ 実質値については、名目雇員報酬を家計最終消費支出（除く持ち家の帰属家賃及びFISIM）デフレーターで除して算出した参考値。
- ・ 本時系列表は、2012年1-3月期以降を掲載している。最新の全計数（1994年1-3月期以降）については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る (純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求められているため)。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
