2. 季節調整は直近値までを対象に毎回かけ直すため、季節調整系列は名目、実質ともに1994年1-3月期まで遡及して改定される。このため常に最新の速報を利用されたい。
3. 本時系列表は、2013年1-3月期以降を掲載している。最新の全計数(1994年1-3月期以降)については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。
