- 季節調整系列については、実額を年率で表示している。
- 実質値については、名目雇用者報酬を家計最終消費支出（除く持ち家の帰属家賃及びFISIM）デフレーターで除して算出した参考値。

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る(純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求めているため)。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
